**Neuro-Ophthalmology Consultation Information**

Welcome to our practice for a neuro-ophthalmological consultation. Please review this information prior to your appointment.

**IMPORTANT:**

1. Please arrive 15 minutes before your scheduled appointment to complete the check-in process. Bring your insurance information and co-payment (if applicable) with you.
2. Allow a minimum of 3 hours to complete your examination and possible testing.
3. Since your examination will cause temporary blurring and light sensitivity, we suggest that someone accompany you to drive you home and that you bring sunglasses.
4. Please complete the information sheet, medication/allergies sheet, and review of systems form and bring them with you
5. If you wear glasses, bring them with you.
6. Ladies, please do not wear eye make-up or perfume.
7. If you are non-English speaking, either bring someone with you to translate or provide us with advance notice to obtain a translator from the hospital
8. If you had laboratory tests performed for your current condition, bring the results with you or arrange to have your physician send them before your visit. If you have seen other physicians whose reports will be helpful, please have them sent as well.
9. If you have had any imaging study (CT or MRI) at an outside facility, **bring the films or CD for review.** You will need to personally request them from the facility that performed the test. The report is not adequate.
10. A detailed report of your evaluation will be sent to your referring physician and primary physician. Please provide the full name, complete address and phone number of all physicians you would like us to correspond with.
11. All patients are scheduled to allow enough time for a complete medical history, examination and discussion of their condition. We do not overbook appointments; patients who do not show up also deprive others who are waiting for a consultation. If you are not able to keep your appointment, please notify the office as soon as possible, preferably 48 hours in advance.
12. New patients who do not keep their appointments and do not give advance notice of cancellation will forfeit their opportunity to reschedule.
13. Diagnostic tests, if needed, are charged in addition to the basic consultation fee.
14. If a physician referral is required for your health care plan, please contact your primary care doctor prior to your appointment to make sure all of the paperwork is completed.

Our office is located on the third floor of Strong Memorial Hospital. A map and directions are enclosed. Free parking is available in the outdoor lot at 210 Crittenden Blvd., at the entrance of the Eye Institute. Alternatively, you may park (for a fee) in the hospital ramp garage. We look forward to your visit and the opportunity to participate in your care.
